

Students aged 65 years or older before the start date of the term are eligible for a senior tuition waiver to audit approved courses. In order to prioritize space for students who are earning credit and paying full tuition, **senior tuition waiver course registration starts on the Monday of the week prior to the start of the term**. This completed form must be submitted in order to receive the senior tuition waiver.

ELIGIBILITY

- Must be 65 years or older and a resident of Oregon at the start of the term in which the course is offered
- Course must be a lower-division college credit course (100- or 200-level, e.g. ART 101, SPN 101, WR 227)
- Some courses have pre-requisites, which must be completed prior to registration or waived by the instructor
- · Waiver may only be applied to a maximum of 8 credits per term
- Course must be audited, meaning that grades and credit will not be granted upon completion, nor will audited classes satisfy graduation requirements, veteran's certification requirements, or most financial aid requirements
- Must have submitted an application for admission to the college prior to registration: www.clackamas.edu/apply

IMPORTANT NOTE: The senior tuition waiver only waives the cost of tuition. Students are responsible for any fees associated with the course, as well as any general student fees.
